ROTATION DESCRIPTION

The Medication Use Management (MUM) rotation is a one-week rotation that provides the Pharmacy Resident with training and experience in provincial hospital formulary management. The rotation is based at the Royal Jubilee Hospital (RJH). Rotation time will be divided between didactic teaching, observation and participation in formulary-related meetings, and work on individual or group assignments. Assignment work will involve an opportunity to practice scholarly writing, which will be formally evaluated. The resident will have an opportunity to meet with the preceptor daily. The resident will be provided with informal feedback during the rotation and a formal rotation evaluation will be completed at the end of the week.

GOALS

- 1. Manage and Improve Medication-Use Systems: The resident shall demonstrate a working knowledge of medication-use systems, as well as the roles of pharmacy personnel and other care providers within the system, in order to manage and improve medication use for individual patients and groups of patients.(2018 CPRB 3.2)
- 2. Gain exposure to and familiarity with the role that Medication Use Management has in the delivery of safe, effective, and financially prudent pharmacotherapy.

ROTATION SPECIFIC OBJECTIVES

The resident will be able to:

- 1. Verbally explain the role and responsibilities of a MUM Pharmacist.
- 2. Verbally summarize the key components of the BC Formulary System Medication Policies B.05a-e.
- 3. Verbally summarize the key components of the Special Access Program (SAP) Policy XXXX
- 4. Verbally summarize the roles and relationships between the BC Drug Review Subcommittee (BC DRS), the BC Health Authorities Pharmacy & Therapeutics (BCHA P&T) Committee, and the Island Health Therapeutic Stewardship and Safety Quality Council. (2018 CPRB 3.2.2)

- 5. To engage in the BC Formulary System by participating in a written provincial formulary review and/or producing a Situation-Background-Assessment-Recommendation (SBAR) document (2018 CPRB 3.2.2).
- 6. To discuss a past drug usage evaluation and/or other key project. (2018 CPRB 3.2.2)
- 7. To demonstrate an understanding the BC Formulary Budget Impact Analysis (BIA) process.
- 8. To demonstrate an understanding of the impact and complexity of drug shortages. (2018 CPRB 3.2.2)
- 9. To verbally discuss (with examples) how communication tools (paper, electronic, and verbal) are used efficiently and effectively manner. (2018 CPRB 3.2.2)

REQUIRED ACTIVITIES

- 1. Engage in a didactic discussion regarding MUM rotation objectives.

 Residents will be evaluated for engagement by their level of discussion participation and their asking of questions to clarify issues.
- 2. Complete the assigned readings.

 Residents will be evaluated for knowledge by their answers to preceptor questions at wrap-up.
- 3. Complete a writing assignment. A Formulary evaluation or related guidance document may be submitted to the British Columbia Health Authority Pharmacy & Therapeutics (BCHA P&T) Committee and/or the Therapeutic Stewardship and Safety Quality Council (TSSQC).
 - Residents will be evaluated for writing skills (see Evaluation of Scholarly Writing Skills Form in one45.com).
- 4. Participate in the discussion of a past Drug Use Evaluation (DUE) project and/or other key project.
 - Residents will be evaluated on their understanding of the objectives and methodology involved in DUE and how to best obtain high quality data.
- 5. Participate in a BC Drug Review Subcommittee (BC DRS) meeting teleconference on August 25, 2020.
 - Residents must complete their BC DRS experience by documenting their thoughts in their records.
